Our efforts focus on saving Amazon rainforest and Andean cloud forests, two of the richest biomes on Earth that hold a vast amount of our planet's biodiversity yet are being rapidly destroyed. We also assist in building the capacity of local conservation organizations to achieve on-the-ground results in natural area and biodiversity conservation. This year's grants were allocated to local conservation organizations and programs in Argentina, Bolivia, Brazil, Colombia, Ecuador, and Peru.
